

Subject: APHIS Adds 24 Counties in Iowa to the Emerald Ash Borer (*Agrilus planipennis*)  
Regulated Area

To: State and Territory Agricultural Regulatory Officials

Effective immediately, the Animal and Plant Health Inspection Service (APHIS) is adding the following Iowa counties to the list of regulated areas for the emerald ash borer (*Agrilus planipennis*):

APHIS is taking this action to respond to the confirmation of emerald ash borer (EAB) in three additional counties in Iowa and known patterns of movement of regulated articles in Iowa.

The attached Federal Order outlines specific conditions for the interstate movement of EAB-regulated articles from the regulated counties in Iowa to prevent the spread of EAB to other states. Specifically, the interstate movement of EAB-host wood and wood products from quarantined counties in Iowa is regulated, including firewood of all hardwood species, nursery stock, green lumber, waste, compost, and chips of ash species.

EAB is an invasive wood boring beetle that is native to China and other areas of East Asia. The beetle is present in some portions of the United States, and because of its continuing spread, APHIS has established regulated areas that are designated in the *Code of Federal Regulations* at 7 CFR 301.53-3 and the Federal Orders located at:

The interstate movement of firewood from quarantine areas is an especially high-risk pathway for the spread of EAB. Therefore, APHIS works with state cooperators and foresters to prevent the human assisted movement of EAB, develop biological and other controls for EAB, and raise

public awareness about this pest and the potential threats associated with the long-distance movement of firewood.

## FEDERAL ORDER

### Domestic Quarantine of 24 Counties in Iowa for Emerald Ash Borer (*Agilus planipennis*)

DA-2014-01

The purpose of this Federal Order is to prevent the spread of the invasive wood-boring beetle known as emerald ash borer (*Agilus planipennis*). This Federal Order is issued in accordance with the regulatory authority provided by the Plant Protection Act of June 20, 2000, as amended, Section 412(a), 7 U.S.C. 7712(a). The Act authorizes the Secretary of Agriculture to prohibit or restrict the movement in interstate commerce of any plant, plant part, or article if the Secretary determines the prohibition or restriction is necessary to prevent the dissemination of a plant pest within the United States. This Federal Order is also issued pursuant to the regulations promulgated under the Plant Protection Act and found in the *Code of Federal Regulations* at 7 CFR 301.53.

Effective immediately, this Federal Order quarantines the following Iowa counties for emerald ash borer (EAB):

This action responds to recent detections of EAB in Iowa. To prevent the spread of EAB, the Administrator of the Animal and Plant Health Inspection Service (APHIS) finds it necessary to regulate these counties. Effective immediately, all interstate movement of EAB-regulated articles from the counties listed above must be done in accordance with the regulations promulgated pursuant to the Plant Protection Act found at 7 CFR 301.53 et seq. and any applicable provisions of this Federal Order.

APHIS has confirmed EAB infestations in various areas of the United States. To prevent the spread of EAB from those areas, the APHIS Administrator has determined those areas must be quarantined. The affected areas are designated in the federal regulations located at 7 CFR 301.53-3 and the Federal Orders located at:

Section 7 CFR 301.53-3(a) allows the designation of less than an entire state as an EAB quarantined area only when the APHIS Administrator has determined—as in this case—that the designation of less than an entire state as a quarantined EAB area is adequate to prevent the interstate spread of infestations of EAB. In addition, 7 CFR 301.53-3(a) requires that the state enforce an intrastate EAB quarantine that is equivalent to the federal EAB regulations. The state plant regulatory official for Iowa has confirmed the establishment of an intrastate quarantine for the regulated area that mirrors the federal regulatory requirements as specified in 7 CFR 301.53.

Section 7 CFR 301.53-3 (b) provides for the temporary designation of new quarantined areas pending publication of a rule to add counties to the list shown in 7 CFR 301.53-3(c). Furthermore, Section 7 CFR 301.53-3 (b) requires written notification to the owner or person who possesses a newly quarantined area. This is the responsibility of the federal and/or state regulatory personnel who are responsible for the EAB program in the affected state.

Previous Federal Orders pertaining to the expansion of quarantined areas in the EAB domestic regulations have been necessary because of the continuing spread of EAB. This Federal Order further expands the quarantined areas as described in the previous EAB Federal Orders.
